Dear Justice Gorsuch:

Please find enclosed and file to the SCOTUS system my Notice of Appeal to the Supreme Court of the United States from the Court of Appeals for 4th Circuit, Docket No. 25-1183, and US District court ED North Carolina, No. 24-CV-00082-M-KS. Enclosed also are my petitions to US President Trump, US Attorney General Bondi, FBI Director Patel, US Attorney for EDNC Boyle, and US Lawmakers: **"Urgent Petition to Cleanse Augean Stables of Deep State Swamp. You have assembled a team of Herculeses; they have to re-route a hundred of rivers to cleanse the stables. Use the big river of grassroots supporters, use National Guard, military, and impose the martial law, to avoid civil war and collapse of the USA. Support my appeal to the Supreme Court of the US. Prevent further damages to US National CBRNE Security. Investigate attempted-murder, RICO, Kids-for-Cash-NC, extortion, plundering, and racketeering crimes in North Carolina. Impose victim protection program."**

I am a scientist, not a lawyer. I have 5 biological children and 5 step-kids; for their better future in the US, I am taking significant amount of time from my project www.tirf-labs.com/i-diagnostics/ to fight against the industry of crimes in North Carolina. I am shocked that these crimes are ongoing routinely at large scale, in numerous courts, law-enforcement agencies, legal and other organizations in North Carolina. The FBI agent AJ Maurer will confirm.

Instead of working on my professional *i-Diagnostics* project, which is of paramount, existential importance for the entire mankind, I have to fight against attempts to murder me, other crimes and corruption in the American legal system, the system which has been designed to maintain **the rule of law, not the dominance of crimes**. I am not stupid, I have been trained by 4 Nobel Prize winners and dozens of other brilliant American, German, and Russian scientists. In 1994 I immigrated to this country, admitted in the for-merit category of "Outstanding Researcher and Professor". By 2001 I achieved the American dream, created 150+ high-tech jobs, contributed significantly into prosperity and CBRNE security of the USA. At the present time, when we are again at the verge of devastating pandemics, instead of working on *i-Diagnostics* project, I have to fight against crimes and corruption in courts.

I have never felt myself as a second-class person, before I came to American courts. My Ph.D. advisor Academician N.N. Semenov took me to help him everywhere, including Kremlin palaces. Here, in the US, I feel myself more patriotic American than my US-born fellows, because this country has recognized and awarded my work and my talents in the way, I even didn't dare to dream about in Russia. I am successfully navigating along many bureaucracies, including the most sophisticated bureaucracy on the globe – that of the US Department of Defense.

However, American judiciary is the world-champion of bureaucracy and corruption. I feel myself as a third-class citizen in the front of the cynical closed-club doors, club filled with gangsters. Millions of Americans gave up to attempt to enter these **"closed-club"** though **gatekeeping** "rules", pro-criminal "orders" favoring crimes, damaging law-abiding citizens, citizens from the core of US nation. The most crooked language on the globe: **"... failed to state a claim..., no jurisdiction...etc, etc"** is translated into plain English with a crystal-clear phase: **"...this is a closed-club, we serve exclusively to the industry of crimes..."** Urgent fundamental reform of American courts is must.

Your body language says that you are a righteous professional jurist of integrity. I request your personal assistance to process my appeals, my fight against the corruption in US judiciary. We must cleanse the Augean stables of deep state swamp, to avoid civil war, to prevent collapse at the terminal phase of cliodynamic cycle.

We, The People of USA gave President Trump overwhelming mandate to cleanse Augean stables of deep state swamp. President Trump has assembled excellent team of Herculeses. We, The People enthusiastically support all your team. Protect yourself and your team from assassinations. The Herculeses have to re-route a dozen of rivers to flush crimes and corruption from Augean stables. We, The People, urge you to use the river of your grassroots supporters. Use National Guard, military, and impose the martial law, if necessary. But do not neglect the river of grassroots.

Judicial reform is the most urgent need to cleanse. 70% or more of American judges (~27,000) are Judges of Integrity. They are vitally interested in returning the rule of law to American soil, cleansing the judiciary from ~7,000 of corrupt traitor-judges. Help us, your grassroots, to help the Herculeses. Open the closed club of US judiciary. Remove formal and informal 'gatekeepers', and let us to sue corrupt traitor-judges for the damages. Similar to corruption in Pennsylvania, similar to Kids-For-Cash scheme, where corrupt judges Ciavarella and Conahan were imprisoned, the FBI Hercules absolutely needs our grassroots river to cleanse the judiciary stables. I am Dr. Alexander Asanov, expert in the area of defense against CBRNE threats. I am an independent scientist. I am not affiliated with any political party and do not depend on any large corporation or a group of special interests. My professional work is of paramount importance for US National CBRNE Security. I am working for better future of my 5 biological and 5 step-children. At the verge of new pandemics my diagnostic products and services are critically important for minimizing the risks of death and damages for hundreds millions of Americans. I am your enthusiastic supporter, voted for President Trump in 2016, 2020, and 2024. My unique professional skills can be of great help to Secretary RFK Jr. and Dr. Steven Hatfill. Four Nobel Prize winners and several dozens of other brilliant scientists trained me. My set of skills uniquely well suits to the field of biodefense and CBRNE security.

Additionally, I am suing corrupt judges, including traitor-judge Merchan, NYC. I am not a lawyer and understand that I have slim chances to win lawsuits against traitor-judges. But I started to sue notorious judge Merchan in August 2024, soon after July 13, 2024 assassination attempt. I am driven by motivations similar to that of Secretary RFK; to look at the mirror without shame. My webpage <https://tirf-labs.com/maga-maha/> contains links to my lawsuits against corrupt traitor-judges, including my recent Notice of Appeal to the Supreme Court of the United States.

I am truly independent, unlike many of CDC, FDA, NIH, NSF and EPA scientists and administrators, who have been bought by big pharma. My knowledge and scientific standing are in line with that of Secretary RFK, Dr. Bhattacharya, Dr. Makary, and EPA Director Zeldin. On behalf of other independent scientists I assure you that we enthusiastically support Secretary RFK Jr., Dr. Hatfill, and all your other team members. Let me help you to MAGA and MAHA.

In 2019-2024 I survived 3 attempts to murder me and am again under the imminent risk of murdering by the vicious organized criminal group Kids-for-Cash-NC. I am urging you to impose the victim protection program onto my family and me. In 2022-2023 the FBI agent AJ Maurer helped to stop attempts to murder me. He showed that Cary police and Wake County sheriff serve to criminals and will not protect me. In fact, the criminals used police, sheriff and District Attorney as a crime weapons in their hands to kill me and to seize my property. When I survived, they used Kids-for-Cash and RICO schemes to plunder \$400,000 from me, which was my post-marital property acquired AFTER my marriage ended. It is difficult to imagine that such cynical outrageous crimes happen in the USA. The organized criminal group consists of 2 recidivist-murderers, illegal-aliens Ms. Olena Kravets and Ms. Olga Petrova. They conspired with coyote lawyers Tanya Plekan, Belinda Sukeena, Elysia Prendergast, Jonathan Richardson, Daniel Krnchavek, corrupt traitor-judges Bell and Ratledge to commit horrible crimes, abusing the court and legal system as weapons for committing their crimes. I have overwhelming body of evidence about their crimes, including files accumulated by the FBI agent AJ Maurer. Agent Maurer told that the traitor-judges delete evidence of their crimes from court files; I have copies on my files. I am in contact with 18 other victims of similar Kids-for-Cash-NC crimes in NC. We estimate that there are tens of thousands of similar victims in North Carolina. It is an industry of crimes similar to Kids-for-Cash in Pennsylvania. It took several years and several thousand kids sold to slavery, before the FBI investigated and traitor-judges Ciavarella and Conahan were imprisoned in Pennsylvania. Corrupt NC traitor-judges Ratledge and Bell, established similar **RULE OF CRIMES** in North Carolina. I urge you to investigate their crimes without any delay.

There are ~34,000 judges in the US and most of them, ~70% or more, are judges of integrity. ~27,000 of them are vitally interested in returning the rule of law to the US. Honorable Judge Ashleigh Dunston, Honorable Judge Vartan Davidian, Honorable Judge Louis Meyer and other belong to Judges of Integrity. They uphold the rule of law and do not cooperate with each other, unlike corrupt traitor-judges and coyote-lawyers, who are serving to criminals. They closely conspire with each other to destroy and intimidate their victims. On behalf of millions of parents and hundreds of millions of US citizens I am urging you to investigate their crimes.

Every human life is unique. The uniqueness of my life involves my unique professional skills and my unique experience in the area of chemical and biological (CBRNE) security, as mentioned before. I was fortunate to assemble a team of super-talented scientists and engineers and together we contributed much to prosperity and security of Americans. It took from us 25+ years of hard work to create our unique CBRNE security facility - TIRF Labs to prevent pandemics and minimize the damages from existing diseases. It took only 2 days of recidivist-murderers' gang crimes to destroy our unique lab. US Federal Court for ED NC made pro-criminal ruling and dismissed my lawsuit against the organized criminals, because the gang includes traitor-judges. I appealed, but the Court of Appeals for 4th Circuit made pro-criminal ruling as well. On January 23, 2025, you, Ms. Bondi during US AG Nomination Hearing, stated that *2/3 of Americans lost their faith to judiciary and continue losing it*. Indeed. The FBI Director Patel outlined in his book "*Government Gangsters*" how deep and rotten the swamp of Deep State is. Although you have adequate insights about necessary reforms from the inside of the beast belly, your plans appear to be too optimistic. Remember, how many voters gave mandate to The President Trump in Washington DC? Only 5% or less! More than 95% support deep state swamp and rotate the \$5 Trillion flywheel of crimes. The number 95% shows that so many deep state actors serve to criminals, serve to anti-American purposes. Their overall number is too high to be overly optimistic. We, The People are here to help you.

Since January 2025 the flywheel of the industry of crimes committed several new criminal circles. More corrupt traitor-judges and more coyote-lawyers came to the surface and exposed themselves. On behalf of hundreds millions of Americans, I am urging you to take intense actions to return the rule of law to American soil as soon as possible. We must see millions of imprisonments in the near future to avoid the civil war. We, The People, are urging you: In addition to reforms that you, Mr. Patel, described in your book "*Government Gangsters*", you must pursue the purpose to incarcerate MILLIONS of criminals from Deep State swamp. Incarcerate the anti-American traitors, including the 60 gangsters, whom you listed at the end of your book. Hundreds millions of Americans will enthusiastically support you. President Trump should not hesitate to involve National Guard, military, martial law, and all other reserves, if necessary. Otherwise, it will be a new civil war. To avoid the war, it appears absolutely necessary to return the rule of law to American soil – incarcerate millions. See below DOGE's and my estimates for the industry of crimes.

In addition to your efforts, let us, The People of the USA, sue the criminals for compensatory and punitive damages in state and federal courts. Open the courts for everyday citizens. At the present time North Carolina state courts and federal USCNCED court are "*closed clubs*" that serve to criminals. There are formal and informal gatekeeping rules, tools and mechanisms that are designed to serve the criminals and to establish the rule of crimes in North Carolina. Many my neighbors, friends and colleagues do not trust that significant changes are possible. Please review carefully my civil class actions filed to the USCNCED and the Court of Appeals. Visit my webpage <https://tirf-labs.com/maga-maha/> to learn about a number of our lawsuits. Please do NOT underestimate the power of grassroots movement. I am a scientist, a naturalized citizen who has achieved the American Dream. I have contributed much into prosperity and CBRNE security of American nation. Help me to involve honest patriotic lawyers who are interested in returning the rule of law; we will give you a powerful driving force.

Currently, the U.S. is in the **terminal phase of a cliodynamic cycle** as outlined at the webpage www.PeterTurchin.com. Back in history, terminal phases often resulted in violent riots and collapses of empires, including Greek, Roman, and Osman. Peaceful resolutions were rare, but possible. Salvador provides a recent example. President Bukele at the terminal phase implemented large-scale imprisonment of gang members, totaling ~2% of population. They attempted to assassinate him and his team members. But now, when Salvador became one of the safest and prospering countries, even his former enemies beg Bukele to take 3rd presidential term. Similar measures are necessary in the U.S. We, the People, gave President Trump a mandate to lead our nation out of this terminal phase— cleanse Augean Stables of the deep state swamp. The first step must be an aggressive reform of the U.S. judiciary, which translates into imprisonment of thousands of corrupt judges – to avoid a civil war.

To prevent a national collapse and civil war, we strongly urge you to address the corruption within the U.S. judiciary without any delay. The court system is the primary tool for cleansing up the rest of the country, and we need its reform to occur swiftly. Similar to Salvador, we should see mass incarceration of insider-criminals, including corrupt traitor-judges and coyote-lawyers. I am writing to let you know that ~80% or more of US citizens support your efforts. Do not reflex to the resistance of the Deep State swamp, even if it includes 220 Nobel Prize winners. They have been bought out by corrupt pharma. We are here to help you. It is estimated that ~7,000 American judges have committed felonies but remain on the bench, posing a direct threat to the integrity of U.S. legal system. They are driving to collapse of the USA and must be removed ASAP to prevent further damage to our nation. We call for the creation of a new U.S. agency tasked with overseeing judicial reform. This agency should be empowered to hire new personnel, remove corrupt actors from office, and, if necessary, involve the military in enforcing these changes, with martial law if necessary.

DOGE estimated that the **flywheel of crimes** in the U.S. amounts **~\$5 Trillion out of ~\$30 Trillion GDP**. These numbers translate into **~8 million** of U.S. domestic felons, maybe including illegal-aliens. There is an army of **~7,000** corrupt judges and **~400,000** coyote-lawyers, the army which serves to the industry of crimes. Despite the fact that 70-80% of judges and lawyers are honest (**~27,000 judges** and **~1,000,000 lawyers**, respectively), the small but dangerous minority of ~7,000 corrupt traitor-judges and ~400,000 coyote-lawyers pose an existential threat by conspiring with criminals. They are like a cancer tumor. Surgical removal of the tumor is urgently needed. We must act swiftly to cleanse the deep state swamp. It requires an army of Herculeases and needs re-routing of several rivers to cleanse the Augean stables, as mentioned above. We propose a nationwide effort to sue corrupt judges through civil class actions, seeking both compensatory and punitive damages for their crimes. Open the doors of the closed-club US judiciary. As the first step, we urge you to advance to the U.S. Supreme Court two of our dismissed appeals in the Court of Appeals for the Fourth Circuit: appeals No. 25-1183 and No. 25-1711, against the notorious judge Merchan, NYC, and NC-state

judges, including judges traitors Bell and Ratledge. The Court of Appeals consolidated with the criminals and denied our appeals. We ask for your assistance to move our appeals to the U.S. Supreme Court. We ask you to involve top-notch lawyers of integrity to help us to sue the corrupt traitor-judges and coyote-lawyers.

Remarkably, U.S. fake-news are shy to report about the crimes committed by American judges. UK-based Reuters has highlighted that "**Thousands of U.S. judges who broke laws or oaths remain on the bench**" [www.reuters.com/investigates/special-report/usa-judges-misconduct]. Lack of judges' accountability underscores the urgent need for cleansing the judiciary. New mass media tools should be created to expose judicial corruption. The time has come; the army of Herculese is ready. *We, The People*, can help Herculese to flood the Augean stables with the river of our civil class actions against corrupt traitor-judges and coyote-lawyers for compensatory and punitive damages. The judicial community has become a closed-club, guarded by formal and informal gatekeepers. We urge you to remove these gatekeepers, open court doors to all Americans, and provide interpreters to translate the crooked language of corrupt judges into English.


To further highlight the need for action, look at the recent example set by HHS Secretary RFK Jr, who fired all 17 members of the CDC vaxxasination panel. All of them operated under the conflicts of interest, conspired with big pharma to commit mass-murdering of vaxxasination and cover crimes of other criminal actors. This courageous move made by RFK Jr. towards restoring trust in U.S. healthcare system is a model for the reforms that we desperately need in American judiciary. A similar step must be taken to dismantle USCNCED, cleanse NC state courts and build a new, transparent judicial system in its place. Move our law-makers to defund the criminal actors and their groups.

FBI Agent AJ Maurer, who was closely familiar with the situation in North Carolina, unambiguously stated that the federal USCNCED and the NC-state courts are NOT governed by the rule of law. USCNCED is totally corrupt; they are serving to criminals throwing the law into dirt, establishing the rule of crimes instead. In 2018-2024 the FBI was too busy raiding Melania's boudoirs, covering Hunter's crimes, fabricating false RussiaGate accusations against President Trump. We urge Ms. Bondi as our U.S. Attorney General and Mr. Patel as our FBI Director to fire corrupt FBI agents and DOJ officers, promote honest FBI agents and DOJ officers, recruit and train new FBI agents, maybe from the pool of ~1 million of honest lawyers. Consider to create a new agency, similar to DHS, which was established after 9-11 attacks. Honest FBI agents should focus on investigating the ~8 million criminals, including ~7,000 corrupt traitor-judges and ~400,000 coyote-lawyers.

As an independent scientist and expert in CBRNE security, I have dedicated my career to advancing the fields of science and technology. However, my work has been repeatedly damaged by corruption within judiciary. If illegal aliens and their gangs would not commit crimes against me, the COVID-19 infection would be localized and its spreading prevented. Recently, the illegal alien, recidivist-murderer Ms. Kravets, who in ~2008 murdered her second husband Volodimir Kravets to seize his property, conspired with notorious traitor-judge Ratledge, and coyote-lawyers Plekan, Sukeena, and Richardson, to kill me to seize my property. In May 2020 I survived her attempt to murder me. To plunder \$400,000 from my post-marital assets, Ms. Kravets conspired with criminal group to plunder \$400,000. As the "side-effects" of their crimes, the consequence is that they destroyed my unique CBRNE lab, TIRF Labs, ~\$60 Million of value. It took 25+ years to create this unique CBRNE facility and only 2 days of crimes to destroy it. Their crimes imposed the risks of death onto hundreds millions of Americans. Returning the rule of law is not just a matter of legal reform; it is a matter of national security.

We, The People urge you to return the rule of law to American soil without delay. We refuse to pay our taxpayers' dollars to anti-American traitors, who support corruption and threaten the security of our nation. A number of NC-state traitor-judges and the entire USCNCED federal court are far more dangerous to the U.S. than any mafia could ever be. Notice of Appeal to the Supreme Court for judiciary reform to avoid civil war. Appeal to cleanse the US legal system from anti-American traitor-judges, exterminating the industry of crimes driven by the army of ~7,000 corrupt traitor-judges and ~400,000 coyote-lawyers, who are serving to ~8 million felons to commit more crimes. The appeal for reforms is addressed to ~27,000 Judges of Integrity, ~1,000,000 honest lawyers, who serve to ~332 million of law-abiding US citizens.

Appeal against - pro-criminal judgment from Feb 12, 2025, in which corrupt federal traitor-judges R. Myers and K. Swank covered attempted-murder, RICO, Kids-for-Cash-NC, plundering \$400,000, Stalin-Beria crimes of the organized group of Appellees-defendants, which includes recidivist-murderers, coyote-lawyers, and corrupt traitor-judges.

Appeal against crimes that damaged National CBRNE Security and inflicted the imminent risks of death and injuries onto hundreds millions of Americans.

Appeal to consolidate into a single case numerous cases criminally disintegrated by corrupt traitor-judges, because all of the cases originate from exactly the same circumstances.

Oral argument requested

Appeal to the Supreme Court to avoid civil war - urgently reform judiciary system, imprison corrupt traitor-judges to return the rule of law to America

To avoid new civil war in this country, We, The People of the USA, urge The Supreme Court of the US to implement urgent judiciary reforms without any delay to cleanse American courts from ~7,000 corrupt traitor-judges, or/and support imposing of the martial law or the state of emergency to return the rule of law to American soil.

The Appellant-plaintiff, Dr. Alexander Asanov, hereafter – Dr. Asanov, on behalf of The People of the USA – hundreds millions of similarly situated victims of RICO, Kids-for-Cash, attempted murders, Stalin-Beria, and other crimes, on behalf of his wife –Nataliia O. Parkhomenko, his children, Daniel A. Asanov, Nicolas A. Asanov, minor children AVK, TVP, and DVP, on behalf of tens thousands of similarly situated children and parents in North Carolina - victims of the Kids-For-Cash-NC, Stalin-Beria falsifications, extortion, plundering, and attempted-murder crimes, on behalf of future generations of American children and parents, urge The Supreme Court to reform American judiciary system. Dr. Asanov urges US federal and NC state lawmakers to defund and disband totally corrupt court units that have degraded beyond the possibility of repair, including:

- **The United States District Court for the Eastern District of North Carolina,**
- **The Court of Appeals for 4th Circuit, and**
- **The General Court of Justice, District Court Division, Wake County, North Carolina**

In parallel with this Appeal, Dr. Asanov petitions US Attorney General Pamela Bondi and FBI Director Kash Patel to urgently investigate, arrest and imprison the organized criminal group of Appellee-Defendants, which includes corrupt NC state and US federal traitor-judges. In parallel with this Appeal Dr. Asanov urges The President of the USA to impose the martial law, or the state of emergency, or design non-standard emergency actions to return the rule of law to American soil to avoid new civil war.

Dr. Asanov shows that the crimes committed against by the organized gang of criminals, which includes corrupt traitor-judges, destroyed his unique CBRNE security facility - TIRF Labs. Their crimes – severely damaged US National CBRNE Security and inflicted the imminent risks of death and injuries onto hundreds millions of Americans.

In similar criminal scheme Kids-For-Cash in Pennsylvania thousands of minor children were sold to slavery. It took ~9 years, before the FBI investigated and imprisoned corrupt traitor judges Ciavarella and Conahan: en.wikipedia.org/wiki/Kids_for_Cash. Urgent FBI investigation is must without any delay.

Case Number 21-CVD-3500 in Wake County Courts and related cases, including Dr. Asanov's appeals, accumulated overwhelming crystal-clear evidence of the Kids-for-Cash-NC, RICO, Stalin-Beria, and other crimes committed by Appellee-defendants. FBI agent AJ Maurer involved two Judges of Integrity, Honorable Ashleigh Dunston and Honorable Vartan Davidian. These Judges of Integrity dismissed fraudulent malicious prosecution that the recidivist-murderer Olena Kravets and her gang pressed against Dr. Asanov. Dr. Asanov survived 3 attempts to murder him in the schemes Kids-For-Cash-NC and RICO crimes. Dr. Asanov is in contact with 18 similar situated victims. They estimate that there are tens of thousands of other victims of Kids-For-Cash-NC crimes in North Carolina.

Dr. Asanov is grateful to FBI Agent AJ Maurer for his preliminary investigation. In 2020-2024, however, the FBI was too busy raiding Melania's boudoirs, contemplating criminal schemes to damage President Trump, and covering numerous crimes committed by Hunter Biden. Not surprisingly, in 2020-2024 the FBI failed to finalize their job – to stop and investigate the Kids-For-Cash-NC, RICO, attempted-murder and plundering crimes committed in the civil branch of Wake County courts. Dr. Asanov urges FBI Director Patel to finalize the investigation of Kids-For-Cash-NC and RICO crimes in North Carolina and to imprison the organized criminal group.

Prevent Further Damages to US National CBRNE Security

The crimes committed by the organized group of gangsters Appellee-defendants destroyed unique CBRNE security facility - TIRF Labs (www.tirf-labs.com), funded by the US Government for the purpose of adequate CBRNE security. The facility was of paramount importance for US National CBRNE Security. The

damage caused by crimes imposed the imminent risks of death and injuries onto hundreds millions of Americans. Corrupt traitor-judges Ratledge, Bell, Young, Eagles, Myers, and Swank, being driven by their criminal pathological desires for self-enrichment by criminal ways, knowingly and willingly committed crimes of attempted murders, extortion, stealing, plundering, vandalizing, RICO, Stalin-Beria, and Kids-For-Cash schemes. Among other injuries and damages their crimes destroyed the unique CBRNE security facility - TIRF Labs, which was of paramount importance for US National CBRNE Security.

Dr. Asanov urges The Supreme Court to prevent further damages to US National CBRNE Security and order that the Appellee-defendants compensate for the damages. As the first step, Dr. Asanov urges the Supreme Court to impose arrests onto bank accounts of the Appellee-defendants.

A cohort of Judges of Integrity in NC state courts, including Honorable Judge of Integrity Ashleigh Dunston, Honorable Judge of Integrity Vartan Davidian, Honorable Judge of Integrity Louis Meyer, are interested in returning the rule of law to American soil. However, vicious gang of corrupt traitor-judges, including NC state judges J. R. Ratledge, J. Bell, R. Young, M. Eagles, seized the control in courts. Judges of Integrity act independently, while corrupt traitor-judges closely conspire with each other to commit their crimes and cover the crimes committed by other gang members. They cover felony crimes of each other, abuse corrupt NC state law enforcement agencies as crime-weapons in their bloody hands.

US Federal court for ED NC, and its corrupt traitor-judges R. Myers, K. Swank, L. Flanagan knowingly and willingly commit crimes in their high US federal offices; they cover the crimes committed by their comrades gang members in NC state court, cynically bend the rules of courts in favor of their criminal comrades and abuse US Federal courts to issue pro-criminal rulings, intimidate and further damage their victims.

The Court of Appeals for 4th Circuit rubber-stamps pro-criminal rulings of their gang members from lower Federal and State courts. These court units systematically serve to the industry of crimes. They have degraded to the level beyond repair. We The People of USA urge the Supreme Court and our Federal and NC state lawmakers to defund and disband these corrupt courts and replace them with respective entities created anew.

Corrupt anti-American traitor-judges R. Myers, L. Flanagan, and K. Swank; have degraded to the level, where they cynically serve to criminals, cynically issue pro-criminal ruling, turn their blind eye towards terrible crimes of their gang members. Corrupt anti-American traitor-judges commit vicious crimes under the color of justice - they knowingly and willingly cover crimes committed by their comrades corrupt traitor-judges of NC state, County of Wake, including traitors J. R. Ratledge, J. Bell, R. Young, and M. Eagles.

Honorable FBI agent AJ Maurer, after he stopped a small fraction of their crimes, before he underwent cancer surgery and discontinued to respond, showed that neither NC state, nor US Federal court uphold the rule of law, but systematically knowingly and willingly cover crimes committed by their comrades corrupt traitor-judges from NC state courts.

The reforms are urgently necessary to cleanse the Augean Stables of deep state from excrements of judicial corruption, to remove large cohorts of coyote-lawyers and traitor-judges who serve the industry of crimes of deep state. The deep state swamp is too deep and too vast. It will take an army of Herculeses to reroute hundreds of rivers to cleanse the corruption and to stop systematic felony crimes. The envisioned reforms or/and martial law are urgently necessary for cleansing of Augean stables to avoid civil war.

Cliodynamic cycles. This life continues, because ~70% of people or more are righteous and honest. However, by the end of terminal phases of cliodynamic cycles (www.PeterTurchin.com) parasitizing cohorts are overproduced; criminals became unbearable burden to society. Sinecures, freebies, massive corruption, open borders, moral degradation, etc. often resulted in civil wars, riots and collapses of Greek, Roman, Osman and other empires.

Peaceful resolutions were seldom, but possible. Recent example is provided by El Salvador, where President Bukele imprisoned ~2% of population – mainly gang members. His efforts took El Salvador from the bottom of bad crisis to prosperity. In 2019, his enemies desperately attempted to assassinate him. In 2025, even his former enemies are begging Bukele to take 3rd presidential term.

For the US with ~340 million of population, respective numbers for terminal phase translate to ~8 million of imprisoned felons to return the rule of law to American soil. Such large changes are necessary and are possible only upon critical reforms of the US judicial system.

There are ~34,000 judges in the US; ~27,000 of them are Judges of Integrity. They are interested in cleansing the judiciary from ~7,000 of corrupt traitor-judges, who committed felonies, but remain at the bench. US fake-news outlets are shy to inform about crimes of American judges; UK outlet Reuters reports about thousands of American judges who committed felonies, but remain at the bench: www.reuters.com/investigates/special-report/usa-judges-misconduct/. There are ~1,400,000 of lawyers in the US; ~1 million of them are honest and are interested in cleansing the lawyers' community from ~400k of coyote-lawyers. The army of ~7k corrupt traitor-judges and ~400k coyote-lawyers is serving to ~8 million of US felons. According to DOGE this army of traitors and felons rotates gigantic ~\$5 TRILLION USD flywheel of the industry of crimes, which comprises 17% of the ~\$30 Trillion US GDP. It is too large portion to be dissolved without a judicial reform or the martial law. We, The People of the USA are vitally interested in extermination of this army of felons ~7k/400k/8,000k, which drives the ~\$5 Trillion USD industry of crimes. This army is behind the assassination attempts against President Trump, VP Vance, RFK Jr., Elon Musk and other Trump's team members. These criminals are responsible for assassination of Charlie Kirk.

On Jan 15, 2025, the Honorable U.S. Attorney General, Pamela Bondi, stated at the Senate confirmation hearing: "*... two-thirds of Americans have lost faith in the Department of Justice, and ... I believe, people continue to lose faith.*" NC data show that ~90% do not trust American judicial system anymore.

The Appellee-defendant, the FBI failed to do its job of protecting US citizens from crimes in 2020-2024, while the Appellees-defendants-criminals - Belinda K. Sukeena, Tanya A. Plekan, Julie L. Bell, John Brian Ratledge, Rhonda G. Young, Olga S. Petrova-Asanov, Olena M. Kravets, Robert P. Taylor, Michael J. Hokenberg, and Joe Doe – unidentified yet Appellees-defendant-criminals, conspired into the organized criminal group to commit RICO-Kids-For-Cash-NC, attempted-murder, extortion, plundering, Stalin-Beria schemes, and other crimes. Their crimes imposed EXISTENTIAL threat onto US nation and inflicted imminent risks of death and injuries onto hundreds millions of Americans. Dr. Asanov urges the Supreme Court to implement judicial reform, which would cleanse US judiciary from corrupt traitor-judges to avoid new civil war.

Dr. Asanov brought this civil class action to lower courts against RICO, Kids-for-Cash-NC, attempted-murder, extortion, plundering, Stalin-Beria, victim/witness intimidation, and numerous other crimes committed by the organized group of defendants-criminals in the period 2018-2024. Many of their crimes defendants-criminals committed under the color of justice – the most vicious, evil, anti-social, anti-American treason crimes that put the US nation into the current crisis, where justice system is severely broken and partially serves to criminals, recidivist-murderers, and illegal-alien, rather than to law-abiding U.S. citizens.

The criminal gang includes recidivist-murders illegal-alien defendants Olga Petrova-Asanov, Olena Kravets, coyote-lawyers Belinda Sukeena, Tanya Plekan, and corrupt North Carolina State judges, including Julie Bell and Brian Ratledge. Their crimes represent a fraction of large criminal industry of Kids-for-Cash and RICO crimes that led this country to terminal phase of the cliodynamic

cycle. Frequently in history the terminal phase resulted in civil wars; peaceful resolutions were seldom. On November 5, 2024, We, The People of the USA, gave to The President Trump massive mandate to rectify this crisis and to drain the swamp of Deep State corruption peacefully. President Trump must perform well-controlled demolition of the corruption in the deep state swamp. Massive extermination of corrupt cohorts of deep state elites is absolutely necessary.

The pro-criminal judgement made in lower courts under the conflict of interest and involved numerous violations of judicial standards and U.S. Code of Laws. Pro-criminal judgements exploited Tunnel-Vision corruption to turn blind eye towards the results of FBI investigation and impartial ruling of four NC Judges of Integrity. Pro-criminal judgment rewarded criminals for attempted-murder, plundering \$400,000, RICO, Kids-for-Cash crimes, and for damage to U.S. National CBRNE Security.

This civil action and this appeal against pro-criminal judgement pursue several goals. One of them is - exterminating the judicial corruption in NC State and U.S. Federal courts.

Overwhelming body of evidence

Dr. Asanov and 5 of his children survived several counts of attempted-murder crimes and numerous other crimes committed against them in Kids-for-Cash-NC and RICO criminal schemes. Dr. Asanov is in contact with 18 (eighteen) similarly situated victims of the Kids-for-Cash-NC and RICO crimes in Wake County, NC. There are estimated TENS OF THOUSANDS of similarly situated victims of the Kids-for-Cash-NC and RICO crimes in North Carolina. There are thousands of pages of documents in Wake County courts and court records that contain overwhelming body of evidence about the crimes under consideration. Preliminary FBI investigation performed by Honorable FBI agent AJ Maurer contains rock-solid evidence about the crimes committed by Defendants-criminals. Before his cancer surgery, FBI agent Maurer warned that the Defendants-criminals contemplate a new wave of their crimes to plunder, steal \$400,000 of Dr. Asanov's post-marital assets, attempt to destroy court records, and commit other misconducts to cover their crimes.

On behalf of tens thousands of similarly situated victims of Kids-for-Cash-NC crimes Dr. Asanov urges U.S. Attorney General Pamela Bondi, FBI Director Kash Patel, and U.S. Border Czar Thomas Homan to investigate the crimes, arrest and deport recidivist-murderers, illegal-aliens Olena Kravets and Olga Petrova-Asanov without delay. They were heavy burdens to their native Russia and Ukraine, committed crimes to invade to the U.S. illegally, and became unbearable burden to Americans. Both of them are suffering from severe mental disorders and are extremely dangerous to society, including their own children. Dr. Asanov urges the government officers to investigate their crimes and arrest the entire organized criminal group of Defendants-criminals, including criminally misconducting judges. Judges are not immune from criminal prosecution and civil responsibility for their felony crimes committed at the bench. Their crimes damaged U.S. National CBRNE Security and imposed the imminent risks of death and injuries onto hundreds millions of Americans. Dr. Asanov is an internationally recognized expert in the area of CBRNE security. He professionally testifies about the damages to U.S. National CBRNE Security caused by the crimes.

Petition to Appoint Appellate-counsel-attorney and Interpreter

"Pro Se" status of this civil action is one of the main reasons for the pro-criminal judgments and anti-American treason crimes committed in the US federal court for ED NC and in Court of Appeals for 4th Circuit. Dr. Asanov petitions the Supreme Court to appoint an appellate-counsel-attorney and an interpreter. Dr. Asanov is 100% certain that the main reason that judges of the Federal district court for Eastern North Carolina and US Court of Appeals committed crimes of covering terrible crimes committed by their corrupt comrades NC state judges and coyote-lawyers, the main reason originates from the "Pro Se" status of this action, from the fact that Dr. Asanov represents

himself in this action. Dr. Asanov and his family members pay taxes to fill salaries of the judicial and law-enforcement officers. Dr. Asanov believes that his family and he are entitled to be protected from the crimes. Corrupt judges committed crimes at the bench under the color of justice and received government representation by numerous counsels to defend their criminal deeds in this civil class action. Their representations were paid by Dr. Asanov and other taxpayers' money.

Dr. Asanov, whose professional service in the area of National CBRNE Security is of paramount importance for security of Americans, requests that the Supreme Court appoints an appellate-counsel-attorney and an interpreter to process this appeal. The closed-club culture of the community of lawyers, which is described by the insider, Honorable John F. Molloy, resulted in gradual degradation of the American justice down to the point, where large cohort of corrupt Judges and coyote-lawyers serve to illegal-aliens and recidivist-criminals and control overall culture in this country. Moreover, the corrupt cohort awards the criminals for their crimes.

Remarkably, Judges of Integrity despite of their majority in the judicial community, are truly independent. They cooperate with the law and judicial standards, while corrupt judges closely conspire with their corrupt comrades, abuse the power of judiciary, which results in a cancer tumor of corruption – relatively small size of the tumor gradually kills the entire organism.

Results of FBI investigation

The Honorable FBI agent AJ Maurer performed preliminary investigation of the crimes and partially stopped a fraction of the Kids-for-Cash-NC and RICO crimes. Before he underwent cancer surgery, FBI agent Maurer warned Dr. Asanov that the same gang of organized criminals contemplates to commit new wave of their crimes, abusing their conspiracy with other corrupt judges and officers of NC judicial system. Agent Maurer also warned that Cary Police serve to Kids-for-Cash criminals and will not protect Dr. Asanov from crimes. Respective documents about findings of the FBI agent Maurer are available in Wake county court files and FBI files.

Independent Impartial Judgements of Four NC-state Judges of Integrity

Four NC-state Judges of Integrity, including Judges Dunston, Davidian, Linardy, and Meyer stopped part of the crimes, because the Judges of Integrity did not cooperate with criminally misconducting traitor-judges and coyote-lawyers – defendants-criminals. Operating under the conflict of interest, covering the crimes committed by his comrades appellee-defendants-criminals, federal Judge R. Myers committed numerous violations of judicial standards, knowingly and willingly committed Tunnel-Vison corruption misconduct and turned his blind eye towards the overwhelming evidence of the results of preliminary FBI investigation and impartial ruling of four Judges of Integrity. Judge Myers committed anti-American treason to reward his comrades Defendants-criminals for their crimes that imposed existential threat onto hundreds millions of Americans. On February 12, 2025, Judge Myers entered the anti-American pro-criminal judgment, which awarded the defendants-criminals for their crimes at the expense of their victims – law-abiding U.S. citizens from the core of American society. This pro-criminal judgement imposed existential threat onto hundreds millions of Americans.

NOTICE OF APPEAL TO THE SUPREME COURT OF THE UNITED STATES

On behalf of The People of the USA, other Appellants-Plaintiffs and himself, Dr. Asanov submits this **NOTICE OF APPEAL** to The Supreme Court of the United States from the final pro-criminal judgment entered in The United States District Court for the Eastern District of North Carolina on February 12, 2025, and pro-criminal ruling of the Court of Appeals for the 4th Circuit.

Attached or embedded into this Notice of Appeal are Petitions addressed to US DOJ, AG Bondi, FBI Director Patel, US President Trump, US Senators Tillis and Budd, Representative Ross, US Attorney for EDNC Boyle for pre-trial injunctions, arrests of the criminals, arrest of their bank accounts, arrest of the plundered, stolen \$400,000 funds of Dr. Asanov, petition for special FBI investigation of the existential anti-American crimes, petition to appoint a counsel-appellate-attorney and an interpreter, the petitions to impose victim/witness protection program and to return guns seized illegally.

Dr. Asanov hotly and strongly protests against the pro-criminal judgements. Operating under the conflict of interest, Judge R. Myers committed the anti-American treason, committed numerous violations of judicial standards, demonstrated criminal incompetence and negligence, exhibited belligerent ignorance, disregarded judicial standards, and disrespected laws stipulated in The Code of Laws of the United States of America.

Dr. Asanov requests The Supreme Court of the United States to consolidate numerous parts of the same line of crimes into a single consolidated file and case. The organized criminal group, which includes coyote-lawyers and traitor-judges intentionally disintegrated their crimes to numerous small fractions to mislead honest actors from the whole picture of their vicious crimes. Dr. Asanov consulted with several top-notch jurists and all of them stated that the numerous parts of these crimes that were intentionally disintegrated by the Defendants-criminals must be consolidated into one, single proceeding, because all of them originate from exactly the same circumstances. To cover crimes of their corrupt comrades the Defendants-criminals and their co-conspirators artificially disintegrated their crimes into numerous cases so that it will be impossible to see the entire picture and to be handled by a reasonable size of judicial team.

Dr. Asanov requests **ORAL ARGUMENT** on his Appeal and on emergency petitions for pre-trial injunctions, specifically on arrests of mentally sick recidivist-murderers, arrests to their bank accounts and application of victim/witness protection programs onto Dr. Asanov and his family members.

In support of his Notice of Appeal Dr. Asanov states the following:

1. Operating under the conflict of interest, having common financial interest with Appellee-defendants-criminals Plekan, Sukeena, Bell, Young, and Ratledge, who belong to the same closed-club professional group of lawyers, U.S. federal Judge Myers and judges of the US Court of Appeals failed to override their nutritional instinct, failed to override corporate animosity against unrepresented litigants, and committed numerous violations of judicial standards and felony violations of the Code of Laws of the United States of America.

2. Dr. Asanov introduces here by reference in its entirety the evidence provided by the prominent insider of the American judicial system – Honorable Judge John F Molloy, the author of Miranda memorandum. In his manuscript *“The Fraternity: Lawyers and Judges are in Collusion”* ISBN-10 : 1557788413, John Molloy shows that due to the organic conflict of interest, judges and lawyers routinely collude with each other against unrepresented litigants driven by their nutritional instincts, because their personal incomes depend on each other, while an unrepresented litigant does not enrich them. In the U.S. such dependence is considered as a conflict of interest. It requires uncompromised moral standards and superior intellectual capabilities of judges and lawyers to override nutritional instinct to rule impartially in accordance with law and Constitution, rather than in illegal interest of their comrades from the closed-club community of lawyers. In 2004 Honorable John Molly foresaw the degradation of US justice system down to very low level to “...make legal services ever more necessary—and more lucrative for the Fraternity...” [nowadays – rather Sorority].

His prediction came into the reality. In 2024 the entire world witnessed disgraceful degradation of U.S. justice system to a lawfare in bloody hands of criminals.

3. Operating under the conflict of interest, Judge Myers and judges of the Court of Appeals failed to override their nutritional instinct and committed numerous counts of crimes, including anti-American treason, criminal negligence and incompetence, Stalin-Beria falsifications, exploitation of Tunnel-vision corruption schemes, knowingly and willingly committed crimes of anti-American treason, at the expense of U.S. National CBRNE Security. These crimes along with pro-criminal ruling of judge Myers and judges of the Court of Appeals imposed existential threat onto millions of Americans.

Dr. Asanov embedded into this Notice of Appeal his petitions for pre-trial injunctions, arrests of the criminals, special FBI investigations of the existential anti-American crimes, appointing a counsel-attorney and an interpreter, the petitions to impose victim/witness protection program and to return guns seized illegally. Dr. Asanov addresses some of these issues in petitions to U.S. Attorney General Pamela Bondi, FBI Director Kash Patel, U.S. Senators Tillis and Budd, US Representative Ross, and US Attorney for EDNC W. E. Boyle.

Criminal Ignoring of the Results of Preliminary FBI Investigation

4. Operating under the conflict of interest, Judge Myers and judges of the Court of Appeals failed to override their nutritional instinct and committed corruption misconduct of intentional overlooking, intentional turning their blind eye towards the results of preliminary FBI investigation. The results of preliminary FBI investigation have been partially accumulated in court files of the Wake County courts. Partially these results have been entered into FBI files.

5. As mentioned before, the FBI agent AJ Maurer performed preliminary investigation of the crimes and partially stopped a fraction of the Kids-for-Cash-NC and RICO crimes.

6. Before he underwent cancer surgery, FBI agent Maurer warned Dr. Asanov that the same gang of organized criminals contemplated to commit a new wave of their crimes, abusing their conspiracy with other corrupt Judges and officers of NC judicial and law-enforcement systems.

7. FBI agent Maurer also warned that Cary police serve to Kids-for-Cash criminals and will not protect Dr. Asanov from crimes. Indeed, Cary and Apex police served to recidivist-murderers illegal aliens Olga Petrova-Asanov and Olena Kravets and did not protect the children and Dr. Asanov from repeated attempts to murder by the recidivist-murderers Olena Kravets and Olga Petrova-Asanov.

8. Defendant Olga Petrova-Asanov suffers from alcoholism. Hundreds of witnesses saw her drunk collapses in public, urination into her pants in public, her anti-social sexual misconduct in public. Behind closed doors Olga attempted to murder Dr. Asanov and younger son, Nicolas Asanov.

9. Defendant Olena Kravets suffers from traumatic brain injury after a motorcycle accident. Additionally, in 2019-2020 Olena contracted cancer tumor in her brain, which caused her sporadic bursts of aggression, including attempts to murder Dr. Asanov. Both Olga and Olena are extremely dangerous to society and must be isolated without delay.

10. It was professional duty of coyote-lawyers Sukeena and Plekan to facilitate mental health evaluation (MHE) and medical treatment to Olga and Olena. Instead, the Defendants-Plekan and Sukeena chose to commit crimes of looting the sick women and exploit them as a crime-weapon in their bloody hands for their pathological criminal goals to enrich themselves by criminal ways.

Criminal Disregarding of Fair Independent Judgements of Four NC Judges of Integrity

11. As mentioned, four NC-state Judges of Integrity, including Judges Dunston, Davidian, Linaryd, and Meyer stopped part of the crimes and did not cooperate with criminally misconducting traitor-Judges and coyote-lawyers.

12. Fair, independent Judgements of these four NC Judges of Integrity are well documented in the Wake County courts files.

13. Operating under the conflict of interest, covering the crimes committed by his comrades Defendants-criminals, federal Judge Myers and judges of the Court of Appeals knowingly and willingly committed Tunnel-vision corruption misconduct, turned their blind eyes towards the overwhelming evidence of the impartial ruling of Judges of Integrity.

14. Operating under the conflict of interest, covering the crimes committed by their comrades Defendants-criminals, federal Judge Myers knowingly and willingly violated the most fundamental judicial standard – give the full faith, treat as true all accusations submitted by plaintiff. Instead, Judge Myers knowingly and willingly violated the most fundamental judicial standard – he gave the full faith and trust to the Defendants-criminals, because they belong to the same group of lawyers.

15. Judge Myers committed anti-American treason to reward his comrades Defendants-criminals for their crimes that imposed EXISTENTIAL threat onto hundreds millions of Americans. On February 12, 2025, Judge Myers entered the anti-American pro-criminal judgment, which awarded the Defendants-criminals for their crimes at the expense of their victims – law-abiding citizens from the core of American society.

16. Dr. Asanov requests **ORAL ARGUMENT** to convey to the Supreme Court evidence about the crimes and against the pro-criminal Judgement entered by federal Judge Myers on 02-12-2025.

17. Under given extraordinary circumstances of the ongoing crisis of legitimacy in the North Carolina state courts, under the circumstances of the dysfunction in 2020-2024 of the Defendant-FBI, under the circumstances of malicious prosecution, abuse and exploitation of the NC legal system by the Defendants-criminals as their crime-weapons for RICO and other felony crimes, under the circumstances of conflict of interest between Judges of this federal Court and the Defendants-criminals, lawyers and Judges, Dr. Asanov submits with his NOTICE OF APPEAL the following emergency petitions:

Emergency petition to U.S. Attorney General Bondi, U.S. Attorney Boyle, and FBI Director Patel - consolidate, investigate and stop Kids-for-Cash-NC, RICO, and other crimes that damaged NC citizens and U.S. National CBRNE Security.

Emergency Petition to arrest and imprison the entire organized criminal gang, including the illegal-aliens, recidivist-murderers, Defendants Kravets and Petrova-Asanov, coyote-lawyers Plekan, Sukeena, Richardson, and anti-American traitors, corrupt Judges Bell and Ratledge.

Dr. Asanov petitions to investigate crimes committed by federal Judges Swank and Myers.

18. Dr. Asanov petitions to investigate crimes committed by Magistrate Judge Swank and Judge Myers.

19. Dr. Asanov petitions to investigate crimes committed by Judges of the US Court of Appeals.

20. Dr. Asanov hereby petitions U.S. Attorney General Pamela Bondi. U.S. Attorney for ED NC W. Ellis Boyle, and FBI Director Kash Patel to investigate and stop Kids-for-Cash-NC, RICO, attempted-murders and all other crimes that damaged U.S. National CBRNE Security. These crimes imposed imminent risks of death and injuries onto hundreds millions of Americans.

21. In his original complaint and subsequent documents Dr. Asanov has clearly demonstrated the facts that attempted-murders, RICO, plundering, Kids-For-Cash, Stalin-Beria falsifications, injured NC citizens and damaged US national CBRNE security. Crimes committed by Defendants-criminals are clearly stipulated in US Federal Code. Defendants-criminals are playing foul play that they do not understand English.

22. To resolve this problem, Dr. Asanov, for the sake of judicial fairness, security of U.S. Nation, and for the sake of judicial economy, requests that the Supreme Court appoints a counsel-appellate-attorney and a qualified interpreter to translate from English to curved language of the closed club of lawyers and vice versa.

23. Dr. Asanov reinstates here his petitions addressed to US Attorney General Pamela Bondi, US Attorney for ED NC W. 25. This civil class action No. 25-1183 (5:24-CV-82-M-KS) is a continuation of the civil action 5:23-CV-00310-M-KS, which was fraudulently dismissed upon criminal misconduct of judicial officers of the district federal court, who operated under the conflict of interest and covered crimes of their felons comrades – Defendants-criminals, including NC state corrupt Judges Bell, Young and Ratledge.

26. Both civil actions brought to daylight the existential crisis of American judicial system, which turned into a banana-republic agency, which serves to criminals at the expense of death, injures and suffering of law-abiding U.S. citizens.

27. Hundreds millions of U.S. citizens are suffering from the industry of crimes. American justice system over the last several years turned into a closed club, which serves to criminals, corrupt Judges, corrupted prosecutors and coyote lawyers.

28. While a significant part of the professional community of lawyers, the majority of it, is represented by honest Judges, prosecutors and lawyers of Integrity, they operate independently and adhere to the letter and the spirit of law and Constitution. Unlike the cohort of corrupted Judges and coyote lawyers - who conspire with each other and commit crimes of covering felonies committed by their corrupted comrades.

29. As the result of their criminal conspiracy, we, the people of the USA, observe that the U.S. justice turned into a machine, which serves to the criminals to reward the criminals for their crimes.

30. We, The People of USA, lost faith in American justice. In fact, the entire world has lost faith in U.S. justice and witnessed the existential crisis in the highest echelons of U.S. establishment.

31. We, The People of USA, demand to return justice to this country. On Nov 5, 2024, we gave overwhelming mandate to the President Trump to cleanse America from banana-republic corruption.

32. This civil class action, like a droplet of water, reflects and refracts the ocean of banana-republic corruption problems in the U.S. justice system.

33. Dr. Asanov requests to consolidate ruling, finding of Judges Integrity, as well as the results of preliminary FBI investigation, into one body to process the entire picture, rather than disintegrate this high-profile crimes and subsequent civil actions into absurdly small fragments.

34. To build a true and complete picture of the terrible crimes and their consequences, the unfinished FBI investigation should be performed in its entirety. Numerous cases that cover the existential crimes committed by the criminal gang should be consolidated into one single case.

35. The Appellee-defendant-criminals persistently attempt to downgrade the attempted-murders, plundering, RICO, Stalin-Beria falsifications, Kids-For-Cash crimes down to a trivial “divorce” turning their blind eyes towards existential felony crimes of the Defendants.

36. Dr. Asanov moves to consolidate all crimes committed by Defendants-criminals, including coyote lawyer Defendant Sukeena and anti-American traitor, corrupt Judge Ratledge, into one case.
